You may withdraw your consent at any time Some of our use of your personal information is subject to the lawful basis of "consent" (you will be able to see where this is the case in the table above). You are able to withdraw your consent to such processing at any time by either contacting us using the contact details set out below or following the "opt-out" link in each communication we send to you. Please note that if you do opt-out we can no longer contact you with the latest news regarding our services.

Where we store your personal data

We will not transfer any personal data we collect from you to a destination outside the European Economic Area.

How do we protect your personal information?

We protect your personal information in the following ways:

- We will not request information which is excessive for our purposes.
- Try, with your assistance, to keep any information we hold about you up to date and accurate.
- Delete any information which we hold about you which is no longer relevant in accordance with our retention policy.
- We follow strict security procedures in the storage and disclosure of information that you have given to us to prevent unauthorised access.
- By having appropriate written agreements in place with those advertisers from which you may request a quote using our site.
